In Sri Lanka, The inability to repay debts led to the Hambantota port being leased to a Chinese company for 99 years, a clear example of the debt sustainability risks faced by BRI investment recipient countries (Weerakoon, 2020). From the perspective of hegemony theory, this study reveals that the BRI serves as a powerful diplomatic tool for China to strengthen political and security ties with other countries. Gramsci (1971) explained that hegemony is not only physical or military dominance but also encompasses ideological aspects, where the hegemonic state influences global values and norms. Through the BRI, China seeks to build alliances and gain political support in the international arena, strengthening its position in competition with the United States. In Pakistan, for example, the strategic partnership between China and Pakistan through the CPEC encompasses not only economic aspects but also close military cooperation.

This collaboration strengthens Pakistan's defense capabilities and enhances China's power projection in the South Asian region (Rolland, 2020). Furthermore, the BRI also has significant implications for political and security dynamics in the Indo-Pacific. China uses the BRI to build strategic alliances with partner countries, strengthening its position in the international arena (Ferchen, 2020). In the Philippines, relations with China are strengthened through BRI investments, despite tensions over territorial disputes in the South China Sea. China's infrastructure development in the Philippines demonstrates how the BRI can be used to strengthen diplomatic ties, despite persistent geopolitical challenges (Beeson & Breslin, 2020). The struggle for hegemony between China and the United States in the Indo-Pacific region will almost certainly trigger an arms race. Competing countries will invest in advanced military technology and weaponry to strengthen their positions. This has significant economic implications and can increase the risk of accidents or conflict escalation (Weerakoon, 2020).

Increased military budgets and high-tech research impose significant economic burdens on these countries, potentially at the expense of other social and development programs. Realist theory in international relations, as outlined by Waltz (1979), emphasizes that countries will always seek to increase their military power as a means of ensuring their security and survival. In this context, the BRI can be seen as China's attempt to enhance its strategic advantage through military modernization and the development of advanced technologies. Control of key shipping lanes in the Indo-Pacific has become a key strategic focal point in economic competition as a tool for achieving geopolitical goals, in line with the realist view of international relations. By understanding how the BRI is used to build alliances,By strengthening political influence and increasing power projection, we can see how this initiative contributes to changing global power dynamics in the 21st century. The BRI reflects Gramsci's (1971) view of

Spykman's Rimland Theory (1944) explains that control of coastal areas and key sea lanes provides significant strategic advantages. In the context of the BRI, shipping lanes such as the Strait of Malacca and the South China Sea are crucial as they serve as vital routes for global trade and the projection of military power. Research by Park and Wisuttisak (2023) highlights how countries in the region seek to secure access and control over these vital sea lanes as part of their geopolitical strategies. The location of military bases and access to military facilities are also important strategic considerations in the competition for hegemony in the Indo-Pacific. Research by Ferchen (2020) shows that China's military presence in strategic areas such as Djibouti is part of its efforts to expand its influence and project power. This military presence not only serves as a deterrent against threats but also strengthens China's political and economic claims in the region. This aligns with Gramsci's (1971) theory of hegemony, which emphasizes the importance of control over strategic infrastructure to achieve political and ideological dominance.

Overall, this study reveals that China's Belt and Road Initiative (BRI) has had a significant impact on global power dynamics in the Indo-Pacific. Through massive investments in infrastructure, China has successfully built strong alliances and strengthened its influence in the region. However, this initiative also faces various challenges, including economic interdependence, financial sustainability, and political risks. The struggle for hegemony between China and the United States in the Indo-Pacific will almost certainly trigger an arms race, control of key sea lanes, and the importance of military bases as strategic focal points. Understanding these dynamics provides important insights for policymakers and academics in developing appropriate strategies to manage the impacts of the BRI and maintain regional stability. By adopting a more inclusive and dialogical approach, China can build more stable and mutually beneficial relationships with partner countries, ensuring that the benefits of the BRI are shared across all parties and contributing to regional stability and prosperity.

Conclusion

The conclusion of this study shows that the Belt and Road Initiative (BRI) initiated by China has become a significant strategic instrument in its efforts to strengthen its hegemony in the Indo-Pacific region, while challenging the dominance of the United States. Through a descriptive qualitative analysis integrating literature and case studies, this study reveals the multidimensional impact of the BRI on the economic, political, and security dynamics in the region. Massive investments in infrastructure in countries such as Indonesia, Pakistan, Sri Lanka, and the Philippines have increased connectivity and driven economic growth, but also pose a risk of high economic dependence on China. The BRI serves as a powerful diplomatic tool for China to strengthen political and security relations with partner countries, in accordance with Gramsci's theory of hegemony. The struggle for hegemony between China and the United States in this region has the potential to trigger an arms race, with control of key shipping lanes and military base locations becoming strategic focal points. Overall, the BRI reflects a paradigm shift in international relations where economic power is used as a primary tool to achieve geopolitical goals, in accordance with the geoeconomic perspective.
